The successful candidate for this post will play a pivotal role in the review and development of the Hospital's long-established adult and later life services and relevant programme (s) in ensuring that services are in keeping with best international practice, taking account of workload allied with the implementation of the Mental Health Act 2001.

This development is part of an emerging vision, which continues to see the growth in service provision, through the development of specialist and tertiary mental health treatment units and programmes.

The post holder will be responsible for the development of a comprehensive range of outpatient Adult and Later Life services at Saint John of God Hospital. It is expected that the appointee will develop programmes in areas including mood/anxiety disorders, psychoses and behavioural and psychological symptoms in dementia (BPSDs).
