# September - December 2019: EAP Summary

# **EAP Q4 HIGHLIGHTS**

- The annual CPsychl Spike Milligan Public Speaking Competition took place in the Button Factory, Dublin on Thursday 21st November. Juan Lopez Tiboni and Emma Pounder, medical students from RCSI, were named the winners on the night for their "culture vs science" take on the theme "Cannabis: Path to Nirvana or Road to Perdition?".
- The REFOCUS Annual Report 2018 has been published and is now available to view on the College website. It was also included in the October 2019 Members' newsletter.
- A College **Harms of Cannabis Committee** has been set up to look at the mental health harms of cannabis and related policy and legislation. The committee has met three times. Draft fact-sheets have been developed around: (i) cannabis and its harms to mental health, educational attainment, work performance and other aspects; (ii) CBD products; (iii) policy around the control of cannabis with the risks/benefits these have on the harms of cannabis. These will have both a medical professional and public education purpose. The drafts will be distributed to College faculties/committees for feedback and then to Council.
- A College Position paper titled "Recovery: Supporting Personal Recovery The Role of the Psychiatrist" has been approved
  and will be designed, published and printed in the coming months.
- The College Professional Ethics for Psychiatrists document has been published, printed and posted to College members.
- Position Papers on (i) Gambling Disorder and (ii) Telepsychiatry have reached the draft stages and will be circulated to faculties
  for comment shortly.

#### AIMS:

To provide support and advice to the College and its members on the ethical dimension of patient care.

To ensure there is an ethical input into College submissions, policy and position papers.

To ensure members have an awareness and expertise in Human Rights Legislation and its impact on mental health care.

- The **Professional Ethics for Psychiatrists** document has been designed, published and printed in full-colour, A5 format and has been recently distributed to members.
- The Committee are preparing a parallel session for the **Spring Conference 2020** in Kilkenny, based on their theme "The Right to Treatment". There is also ongoing discussion on a title for a position paper relevant to this theme which could bring in issues such as the prison and homeless populations, advocacy, whistle-blowing, lack of resources and more.

# Family Carers Ireland (FCI)

Phase 2 report of research carried out on carer health and well-being, titled "Paying the Price: Hidden Impacts of Caring", was launched at the FCI Conference on 17th October 2019. This follow-up report concentrates on safety and exposure to abuse of carers, again highlighting deficits in services, home-support hours, access to respite and safeguarding.

The EAP team met with FCI to discuss further potential media engagement around the phase 2 findings report from January 2020 onwards.
